

#### Dean's Decree No. 2D/2023

# ORGANIZATION OF THE ACADEMIC YEAR 2023/2024 AT THE FACULTY OF ELECTRICAL ENGINEERING OF THE UNIVERSITY OF WEST BOHEMIA

In accordance with the Instruction of the Vice-Rector 2P/2023 Schedule of the Academic Year 2023/24, this Decree specifies the organization of basic study activities in 2023/24 at the Faculty of Electrical Engineering of the University of West Bohemia (hereinafter referred to as "FEE"), and the deadlines for the fulfillment of selected duties.

# Article 1 Term Calendar of the Academic Year

The dates for the organisation of the academic year (usually the deadlines for individual activities) are given in Annex 1 to this Decree.

# Article 2 Mandatory Attendance of Students in Class

In accordance with Article 14 (2) of the Study and Examination Regulations of the University of West Bohemia in Pilsen of 13 July 2017 as amended, students are required to attend:

- a. all forms of lectures in all mandatory and compulsory elective courses of the 1st year of FEE Bachelor's degree study programme in full-time study form,
- b. the first week of each semester, respectively the first consultation in the combined study form,
- c. all practical laboratory and test tutorials,
- d. all tutorials where semester assignments are given,
- e. all tutorials and seminars of the Department of Power Electronics and Machines (KEV),
- f. all education forms of courses KEI/EK, KEP/MOD, KEP/ZPEL, KEP/TEL1, KEP/TEL2, KEP/TEL3, KEP/ED.

## Article 3 Final Provisions

- (1) This Decree shall enter into force on the day of its signature.
- (2) As of September 1, 2023, the Dean's decree No. 6D/2022 Organization of the academic year 2022/2023 at the Faculty of Electrical Engineering of the University of West Bohemia is cancelled.
